SUBJECT: Fiscal Note

Senate Bill 9 (LC 41 0860)

Dear Senator Rhett:

This bill would change the eligibility requirement for former law enforcement officers (LEO) to receive a weapons carry license at no charge. Current law states that former LEOs who have served for 10 of the last 12 years immediately preceding retirement may attain a license without payment. The bill would expand the eligibility to former LEOs who have served for at least 10 years and are receiving benefits from the Peace Officers' Annuity and Benefit Fund or a county, municipal, state of Georgia, state authority, or federal retirement system.

We are unable to determine the bill's precise fiscal impact on the state, but it is likely to be marginal over the current exemption. We could not determine the number of additional former LEOs that would qualify under the bill's eligibility requirements; however, the number of exemptions is not expected to significantly increase.

Applications for weapons carry licenses are initially processed at county probate courts, with specific fees being dedicated to county, state, and federal authorities. The Georgia Bureau of Investigation (GBI) is the only state entity that would be financially impacted by the bill. GBI normally receives \$39.75 per application for fingerprinting services and forwards a fee of \$12 to the Federal Bureau of Investigations for its service. In the last three fiscal years, an average of 800 former LEO exemptions have been granted. This has resulted in revenue loss of approximately \$32,000 annually, but GBI still pays average FBI fees of about \$9,600 for those applications. As shown in Exhibit 1, these exemptions represent a small portion of total weapons carry permits processed by GBI.
