SUBJECT: Fiscal Note

House Bill 717 (LC 33 7832)

## Dear Representative Mathiak:

This bill would provide for the licensure and regulation of midwives and the creation of the Advisory Board for Licensed Midwives (Board). The bill does not specify an agency under which the Board will be created; however, for the purpose of this analysis we assume the Board will be under the Secretary of State's Office, which oversees most professional licensing boards in the state. It should be noted this bill would offer licenses to non-nurse midwives<sup>1</sup> and create the title of Licensed Midwife. Currently, the only licensed midwives in the state are Certified Nurse Midwives (CNMs) licensed by the Georgia Board of Nursing. CNMs would not be subject to additional fees as a result of this bill.

## Costs to the Secretary of State's Office

According to the Secretary of State's Office (SOS), the Board's functions as described in the bill are similar to a professional licensing board, rather than an advisory board as stated in the bill. The estimate is based on costs of supporting a professional licensing board. As shown in **Table 1**, the estimated cost to the SOS to implement the bill is approximately \$260,000 in the first year, with future recurring annual costs of approximately \$170,000.

The personnel costs are associated with 40% to 50% of FTE time for staff performing functions related to licensing, compliance, investigations, intake, and the call center. Operations costs primarily include training, information technology, and the Office of State Administrative Hearings.

## Fee Revenue to Secretary of State's Office

Once established, fees for Licensed Midwives (LM) would be promulgated by the Board. According to the Georgia Midwives Association, there are approximately 30 CPMs currently practicing in Georgia. Creation of the Board could encourage individuals to obtain their professional midwife certification and licensure. Due to the uncertainty of fee amounts that will be set, and number of professional midwives that may seek licensure, we present scenarios of revenues that the SOS may collect.

Costs to the Department of Community Health

This bill would ensure that maternity care services provided by LMs are covered by all forms of health insurance coverage, including Medicaid, and that LMs will be reimbursed at the same rate as other providers of maternity care. In Table 3, we provide estimated Medicaid coverage cost scenarios for licensed midwives services in a year.
