SUBJECT: Fiscal Note

House Bill 910 (LC 33 8184)

Dear Chairman Powell:

This bill would provide for creation of the Advisory Group for Licensed Midwives, which would advise the Secretary of State (SOS) in the regulation of licensing and regulation of midwifery. The bill establishes certification and education requirements for those seeking a license, with the requirements including certified midwives (CM) and certified professional midwives (CPM). The bill does not impact certified nurse midwives (CNM) licensed by the Georgia Board of Nursing.

Costs to the Secretary of State's Office

According to the SOS, the bill would result in one-time and annual costs as shown in **Table 1**. One-time costs of \$80,000 are related to required changes to the licensing information system. Ongoing costs of approximately \$78,000 are primarily related to personnel. The personnel costs are associated with staff performing functions related to licensing, compliance, investigations, intake, and the call center. Operations costs primarily include training, information technology, and the Office of State Administrative Hearings.

Fee Revenue to Secretary of State's Office

Fee amounts would be determined by SOS. According to the Georgia Midwives Association, there are approximately 30 CPMs currently practicing in Georgia. Creation of the Board could encourage individuals to obtain their professional midwife certification and licensure. Due to the

uncertainty of fee amounts that will be set, and number of professional midwives that may seek licensure, we present scenarios of revenues that the SOS may collect.
